MARRIAGE LICENSE

THIS COURT WILL ISSUE MARRIAGE LICENSES. HOWEVER, WE ASK THAT THE PARTIES LIMIT THE APPLICATIONS TO WEDDINGS TAKING PLACE DURING THE TIME OF THE DECLARED EMERGENCY (MARCH 14 – APRIL 14). *IF IT IS ABSOLUTLEY NECESSARY THAT YOU RECEIVE A MARRIAGE LICENSE AT THIS TIME PLEASE CALL OUR OFFICE AT 478-825-2313 TO SCHEDULE AN APPOINTMENT.

WEAPONS CARRY LICENSE

THIS COURT <u>WILL NOT</u> BE ISSUING <u>ANY</u> WEAPONS CARRY LICENSE DURING THE PERIOD OF THIS STATEWIDE JUDICIAL EMERGENCY. IF YOU ARE DUE TO RENEW DURING THE EMERGENCY PERIOD, YOUR LICENSE WILL NOT EXPIRE. YOU WILL BE ABLE TO RENEW AFTER THE EMERGENCY ENDS AND YOUR CURRENT LICENSE WILL REMAIN VALID UNTIL THAT TIME.

BIRTH AND DEATH CERTIFICATES

<u>WE</u> WILL CONTINUE TO ISSUE VITAL RECORDS, WE ASK, IF POSSIBLE, THAT THIS PROCESS BE DONE THROUGH THE MAIL TO AVOID COMING IN TO THE OFFICE. IF YOU HAVE ANY QUESTIONS REGARDING THIS PROCEDURE OR AN EMERGENCY CALL OUR OFFICE.
